# Adviser Development Scholarship

#### Application criteria

- 1. All applicants must be currently registered on the Financial Service Providers Register.
- 2. Applicants do not have to be TripleA member, however if an application is successful non-members must join the Association and maintain their membership for a minimum of two years.
- 3. All scholarship recipients must use the TripleA's preferred PI scheme (subject to approval) and dispute resolution scheme arrangements.
- 4. Scholarship funding is only available for training delivered by Strategi Institute.
- 5. Funding is personal to the adviser and cannot be transferred to another adviser.

#### **Application process**

- 1. Contact Strategi Institute to identify the appropriate course of study for your requirements. Complete the enrolment process and Strategi will provide you with a confirmation of enrolment letter.
- 2. Complete the application form on the next page and forward this, with the required supporting documentation, to <a href="wayne@TripleA.org.nz">Wayne@TripleA.org.nz</a>, within two weeks of the date of your enrolment letter.
- 3. Your application will be reviewed by the board of the TripleA Advisers Association.
- 4. The TripleA will advise you and Strategi Institute of the outcome of your scholarship application within 7 days of receiving all the required documentation.
- 5. Strategi Institute will contact you directly to confirm your start date and invoice you for the full cost of your course.
- 6. Strategi Institute will advise TripleA when you successfully complete the approved course of study.
- 7. TripleA will pay the scholarship funds directly to the recipient's bank account. No other payment options are available.
